Maruzen Pharmaceuticals' officers and employees will work together to ensure that all corporate activities are conducted in a fair and law-abiding manner.

■ Ensure compliance with laws and regulations

Maruzen Pharmaceutical has upheld compliance with laws and regulations in its internal rules and regulations and conducts its corporate activities in strict compliance with laws and regulations. Whenever laws related to corporate activities are enacted or revised, the General Affairs Department takes the lead in notifying the company and ensuring that all employees are fully aware of the changes.

All officers and employees will be subject to disciplinary or other action in the unlikely event of inappropriate behavior.

Directors and employees may consult or report to the "Compliance and Harassment Consultation and Reporting Desk" if they discover violations of laws, regulations, ethics, or other company rules, or if they are subjected to harassment of any kind.

The Consultation and Reporting Desk will examine the information received, accurately grasp the facts, and take corrective measures as necessary. Confidentiality of consultants and reporters is protected, and they will not be treated unfavorably because of their consultation or reporting.



■ Cutting off relations with antisocial forces

Maruzen Pharmaceuticals has declared that it will take a resolute stance against antisocial forces and will sever all relations with them.

■ Compliance with antitrust Laws

Maruzen Pharmaceutical shall comply with the Antimonopoly Law in all areas of production, sales, purchasing, etc., and conduct business activities based on fair and free competition.

■ Prohibition of conflicts of interest

Maruzen Pharmaceuticals does not engage in any acts that benefit individuals based on their position in the company or information obtained in the course of their duties, nor does it engage in any acts that benefit the company or its employees.

The company will not engage in any conduct that conflicts with the interests of the company or the company's employees.

■ Bribery and the giving and receiving of gifts

Maruzen Pharmaceuticals prohibits employees from accepting or offering bribes and does not permit unfair dealings in accordance with internal rules. Official gifts to external parties are also permitted only with the prescribed approval.



From material exploration to product development, Maruzen Pharmaceuticals is committed to responding to customer feedback with analytical technologies and cutting-edge evaluation technologies, and to developing products with an eye toward solving social issues.

■ Natural material search

The search for natural materials is the first step in our research. We pursue natural materials that can meet the needs of our customers and strive to search for useful materials from all over the world, both domestically and internationally. We conduct research on materials we obtain by confirming their scientific names, checking for legal restrictions, and investigating their resources. When acquiring materials, we take into consideration their impact on biodiversity and strive to conserve the natural environment and use them in a sustainable manner.

■ Active ingredient analysis

Active ingredient analysis is performed through separation and purification, structural confirmation, and content analysis of various components contained in natural materials using instruments such as NMR, LC-MS, and SFC to analyze active ingredients and explore the superior functions of natural materials.

■ Bioresearch

In biotechnology research, in order to obtain useful natural materials of stable quality, we conduct research on seedling production using plant culture technology and the use of microorganisms and enzymes to impart new functionality to natural materials.

■ Activity evaluation

Our activity evaluation aims to ensure that our customers can use our products with confidence by evaluating their efficacy utilizing more than 100 different activity evaluation systems to find the bioactivity of natural materials.

■ Extraction and purification technology

Extraction and purification technologies are being studied with the aim of acquiring and installing the latest manufacturing equipment technology in order to utilize new extraction and purification technologies in our own production.



■ Product development

In product development, we aim to propose new products that our customers will be happy to use and that we will create together with them by obtaining natural materials and adding technical development to basic research for use in actual pharmaceuticals, cosmetics, quasi-drugs, and food products.

■ Regulatory compliance

For regulatory compliance, we provide the tools necessary to handle various procedures, including applications for approval of quasi-drugs, as well as our own research on regulatory-related information in Japan and overseas.

■ Patent support and literature search

We view patent correspondence and literature searches as essential rights and information management for our customers to use our products with confidence. We strive to collect and utilize the latest information through literature searches, patent searches, and legal information searches.

■Intellectual property management

Based on our corporate philosophy of continuing to provide the world with the blessings of nature while coexisting with the assets of "people, society, business, and nature," Maruzen Pharmaceutical is working to protect our products by applying for, obtaining, and maintaining intellectual property rights, including patents and trademarks. We also respect the intellectual property rights of third parties by managing intellectual property risks through research of third-party rights.





Maruzen Pharmaceuticals stably supplies reliable products that customers can use with confidence based on our "Quality Policy".

■ Quality assurance

At Maruzen Pharmaceutical, we focus on providing a stable supply of the high quality products demanded by our customers.

We have established a department that assures and oversees overall quality in order to improve customer satisfaction, and we are continuously working to ensure and improve quality.

Maruzen Pharmaceutical's Quality Assurance & Quality Control Division has a dedicated quality control department at each factory that inspects each product to ensure that it meets the company's own standards in accordance with various laws. Our mainstay pharmaceutical licorice-based products are manufactured in a factory that complies with GMP (*). The Miyoshi Factory and related divisions have also obtained ISO 9001:2015 certification (international standard for quality management systems by the International Organization for Standardization (ISO)). *GMP stands for "Good Manufacturing Practice" and refers to the standards for manufacturing and quality control at a manufacturing facility.

■ Quality analysis

Quality inspections by educated and trained inspectors to ensure product quality and improve customer service.

(We aim to achieve zero quality problems by properly implementing the following quality control measures (raw material inspections, in-process product inspections, product inspections, etc.).

We strive for early detection and improvement of problems.

■ Product safety management

Product safety is managed from product development to shipment in accordance with internal regulations. For safety, we assess risks to the environment and health from the design stage. In addition, we ensure that documentation and reporting required in accordance with internal regulations are carried out.

Management & Protection of Information Assets

Maruzen Pharmaceuticals takes optimal management and protection measures to adequately safeguard information assets against threats to their confidentiality, integrity, and availability.

■ Information asset management

As a measure for business continuity planning (BCP) and the preservation of confidential information, we have relocated our server equipment to a high-security external data center to manage our information assets in an optimal environment. Asset information* on IT equipment connected to the network is automatically collected every 24 hours for asset management.

*Model, application, license, user, purchase information, etc.
Internal rules prohibit the leakage of confidential information of business importance to outside parties, causing damage to the company or interfering with the normal operation of business.

■Cyber security

In preparation for cyber attacks, we continue to implement cutting-edge security measures, such as enhanced monitoring through our 24/7 intrusion detection service and measures to prevent secondary infection using infection spread detection technology.

Targeted e-mail attack countermeasure systems have been introduced, not only to prevent intrusion but also to detect and we are also strengthening our measures against analysis.

We conduct annual training against targeted e-mail attacks to raise employee security awareness, and at the same time, we are building a system that can respond quickly in the event of an incident.



■ Privacy

Maruzen Pharmaceuticals fully recognizes the importance of protecting personal information and respects the Personal Information Protection Law, various regulations and guidelines. In addition, employees who manage personal information are audited on a regular basis.

In accordance with the "Act on the Protection of Personal Information," Maruzen Pharmaceutical has established a "Personal Information Protection Policy" to appropriately protect personal information, which is available on our website.

To ensure the proper handling and protection of personal information, education on laws and regulations is provided and monitoring systems are in place.

The protection is provided to prevent information leakage due to theft or loss of PCs, we have implemented measures such as encryption of hard disks and stored data, and cloud-based e-mail management.

In order to encourage appropriate measures for personal information, we have established a "Contact for Questions, Complaints, etc.".

Maruzen Pharmaceuticals promotes initiatives that take into consideration the environmental impact of our business activities in accordance with our "Environmental Policy".

■ Factory initiatives

Maruzen Pharmaceutical established the Energy Management Committee in 2010 to reduce environmental impact.

Annual environmental reports are prepared at all factories. Although the amount of activity at each factory has increased over the years, energy consumption per unit of

activity has decreased over the years due to the installation of new equipment such as high-efficiency boilers and LED lights.

Solar panels have been installed on the Welfare building and the temperature-controlled warehouse at the Shin-Onomichi Factory to provide electricity used at the factory. In addition, the Miyoshi Factory has switched its fuel from

heavy oil to LNG (liquefied natural gas) to reduce CO2.

Simplified product packaging has been introduced to reduce waste.

Wastewater treatment facilities are fully equipped for discharge into the sea and rivers. When wastewater is discharged into the sea or rivers, it is purified by microorganisms. We also manage water quality thoroughly in consideration of biodiversity.

■Office initiatives


In our offices, we not only use LED lights but also turn off lights in unused areas to reduce electricity consumption. We also promote "Cool Biz" and "Warm Biz" and set appropriate air conditioning temperatures.

To reduce paper waste, internal communications are conducted electronically whenever possible, and when printouts are made, recycled paper is used and double-sided printing is implemented as needed.



■ Environmentally friendly Kui Farm

In 2007, Maruzen Pharmaceutical established Kui Farm in Mihara City, Hiroshima Prefecture, with approximately 75,000 m² of farmland, in order to reduce its environmental impact and to test cultivate useful plant materials on its own. At Kui Farm, a recycling cycle has been established by composting extraction residues and cultivating useful plant materials.

■ Quality-oriented

Harassment and abuse


